## ATTACHMENT

(1) POLITICALLY EXPOSED PERSONS

Politically exposed persons means:

a) according to the definition of which - Art. 1, paragraph 2, letter "o" of Legislative Decree 231/07

"Politically exposed people": natural persons who are nationals of other Community States or of non-Community States and who occupy or have held important public positions, as well as their immediate family members or those with whom such persons are known to have close links, identified on the basis of the criteria set out in the technical annex to this decree. b) pursuant to Art. 1 Technical Annex to Legislative Decree no. 231/2007

1. Natural persons occupying or having held important public offices shall mean:

a) Heads of State, Heads of Government, Ministers and Deputy Ministers or Undersecretaries;

b) parliamentarians;

c) members of supreme courts, constitutional courts and other high-level judicial bodies whose decisions are not

generally subject to further appeal, except in exceptional circumstances;

d) the members of the courts of auditors and of the boards of central banks;

e) ambassadors, senior business representatives and officers of the armed forces;

f) the members of the administrative, management or supervisory bodies of undertakings owned by the State.

Middle or lower level officials shall not be included in any of the above categories. The categories referred to in points a) to e) include, where applicable, positions at European and international level.

2. Direct family members shall mean:

a) the spouse;

b) children and their spouses;

c) those who in the last five years have lived with the subjects referred to in the preceding letters;

d) the parents.

3. For the purpose of identifying persons with whom the persons referred to in No 1 are known to have close links: refers to:

a) any natural person known to have joint effective ownership of legal entities or any other close

business relationship with a person referred to in paragraph 1;

b) any natural person who is the sole effective owner of legal entities or legal entities known to be de facto created for the benefit of the person referred to in paragraph 1.

4. Without prejudice to the risk-based application of enhanced customer due diligence requirements where a person has ceased to hold important public office for at least one year.
